We've gotten settled into our new office. We have had several comments on how nice the office looks from property owners who have come in. It's definitely a more efficient working environment.

On September 17th, Lana and I have begun invoicing for 2020 Maintenance Fees. We are continuing to send out lien notices. We hope to have the invoices completed and ready to mail out before the end of October. The office hours during invoicing will be 9:00 a.m. to 12:00 p.m. to allow uninterrupted time to focus on the invoicing.

We have had extra expenses this past month due to election notices being printed and mailed out. We have purchased extra ink cartridges, copy paper, watermarked stationary, envelopes and postage stamps. Part of the extra supplies was for invoicing of the 2020 Maintenance Fees. Expenses for election supplies was approximately \$1400 and invoicing supplies was approximately \$800 for a total of \$2200.
